CBIA Dues

BASIC MEMBERSHIP

For-profit businesses may join CBIA as basic members.

*For companies with an annual Connecticut payroll of \$1,000,000 or more, dues equal \$1,200 + (\$.46 per \$1,000 of payroll in excess of \$1,000,000).

CBIA fees are based on your Connecticut payroll and administered on a calendar-year basis. A member’s initial fee, therefore, is prorated based upon the time of year membership begins.

First-year charges:

- ▶ 1st quarter (Jan., Feb., March) – 100 percent
- ▶ 2nd quarter (April, May, June) – 75 percent
- ▶ 3rd quarter (July, Aug., Sept.) – 50 percent
- ▶ 4th quarter (Oct., Nov., Dec.) – 100 percent (includes following year’s fee)

BASIC MEMBERSHIP: NOT-FOR-PROFIT

Not-for-profit organizations may join CBIA as not-for-profit basic members. Note that we may request evidence of your not-for-profit status.
